
Older people are at the heart of rural communities





Some Rural Facts

- 24% of the rural population is over 65
- Increasing to 29% by 2021
- Overall wealthier and healthier than urban dwellers
- 18% of rural pensioner households live below the poverty line
- 24% of older residents provide care for one another



Some characteristics of rural older person's housing

- 81% are owner-occupiers
- Most poorer owner occupiers cannot afford to buy retirement housing outright
- The choice of housing across all tenures is limited
- Lack of housing with in-home support
- 38% of homes have adaptations (R80s)



The rural problem – The response

Lack of services and choice

- = lack of voicing of need
- = lack of supply
- = action at point of crisis
- = costly
- = reactive not proactive
- reduces opportunitiesfor integrated actionby service providers

What could help – Care Act 2014

- Local authorities must promote wellbeing when carrying out any of their care and support functions in respect of a person.
- Concept of Well Being includes "suitability of living accommodation"
- Shift from providing services to meeting needs
- Six principles that include:
 - Importance of prevention
 - Decisions are made having regard to the individual's circumstances
 - Individual participates in decisions as fully as possible

- •Small dispersed population
- Higher costs of delivery services & housing
- •Juxtaposition of wealth & poverty both with needs
- •Lack of housing choice across all tenures
- Older housing stock
- Poor accessibility: travel broadband
- Loss of informal carers

- Strengthen the rural evidence base
 - Ward Atlas information
 - PoPPI

 Cross-subsidy on rural exception sites includes market housing for local downsizers

Some ideas – More Bell Views




Belford – population 1,000

Closure of NCC owned homes led to massive community action resulting in:

- 5 Bungalows owned and run by Johnnie Johnson HA
- Resource centre leasehold from NCC provides:
 - Low level support to people in their homes
 - Transport and social activities
 - Gym/fresh food/rehabilitation support
- Outreach support to 125 mile radius
