Village and Community Agents are a team of paid workers helping older people maintain their independence at home, facilitate access to services and information and ensure that their clients are able to navigate through what can be a complex, technological world.

Working within their local communities

Vast local knowledge of clubs, groups, facilities, services available close to home

Trusted and valued members of the communities in which they work

Close links and training from local and countywide agencies to signpost appropriately





GRCC initial concept- Responding to the changing environment of rural communities and the need for easier access to information and support locally for older people

Launched in 2006 as a DWP pilot in 96 rural parishes. In 2008 became a mainstream service funded by Gloucestershire County Council and NHS Gloucestershire

Promoting a culture of independence and supporting the prevention agenda

- •National and International exemplar Model replicated by counties around the country including Essex and Somerset and adapted to their particular needs
- •Partnership working and Local Networks crucial to the success of the scheme





Specialisms and Developments

Community Agents working with Black and Minority Ethnic communities were introduced in 2007 to respond to the need in urban areas

- •Additional training for Specialist Cancer Agents began in 2009 as part of the National Cancer Survivorship Initiative and funded through Macmillan.
- In 2012, the Gloucestershire Village & Community Agent scheme achieved full countywide coverage

Economic Benefits

Between 2012 and 2014, the Agents' activities resulted in savings to Gloucestershire Health and Social Care services totalling £1,290,107.42, and financial benefits to individual clients totalling £818,207.24. The cost of the scheme over the same time period was £680,000.

For every £1 that the scheme cost, the return on investment is calculated to be £3.10. This breaks down further as:

£1.90 savings to Gloucestershire Health and Social Care services;

£1.20 financial benefits to clients
