Small grants for village halls – Defra and ACRE (Action with Communities in Rural Areas)

Grants up to £5,000 are available to help make modest improvements to rural community buildings in England such as boiler replacements, insulation, toilet upgrades and new kitchens.

Awards can be made to cover 20% of eligible project costs, up to a maximum amount of £5,000. The balance of funding for the works proposed must be in place or at least confirmed within 6 weeks of making an application to the small grants fund.

Project expenditure must take place before 31 March 2026.

Anchor Fund – Alliance for Youth Organising

The Alliance for Youth Organising will provide anchor grants of £40,000 a year for two years to UK-based organisations that are supporting youth organising.

The purpose of the funding is to support wider access to youth organising and strengthen the youth organising field.

Groups will also receive an additional £5,000 to support learning and to provide strategic insight to the Alliance to shape its future strategy. This means that the total grant awarded is £85,000 over two years.

The Fund will close to applications on 26 January 2026 and between seven and ten grants will be made by April 2026.

Fisheries Improvement Programme 2026 – Angling Trust

Every year the Environment Agency will reinvest about £1M in projects to support clubs, fisheries and other partners to improve local fish stocks and angling opportunities.

The Fisheries Improvement Programme (FIP) is funded from the coarse, trout and eel fishing licence income and provides a direct benefit to anglers. They are initially making £730k available to support projects, most of which are developed and delivered by angling clubs and other partners.

Applications are welcomed from clubs, fisheries, NGOs, local authorities or other community organisations involved in angling. Most projects will receive less than £5000 each. The deadline for applications is 6 February 2026.

Sea Changers Coastal Fountains Fund 2026

The fund aims to protect coastal habitats from the harmful effects of single-use plastic water bottles by supporting communities to purchase water refill fountains for busy or environmentally significant coastal areas.

Grants of up to £2,500 are available, per applicant, towards the cost of a fountain. They welcome applications from all types of not-for-profit organisations who have identified a need and are well-placed to build the stakeholder involvement needed to make the project a success.

The deadline for applications is 28 February 2026.

Quaker Housing Trust

QHT gives advice, support, loans and grants to small charitable organisations to help them provide safe, decent and affordable homes.

They currently offer two separate restricted funding programmes:

- Best practice grants up to £6000 for early in the development of a project to enable projects to reach the highest possible standards.
- The Main Grants and Loans Programme to fund projects which create homes.

For capital projects generating income from rent, trustees will award interest-free loans up to £30,000 with a 5% administration fee payable at the end of the loan period.

The deadline for expressions of interest for the main grants and loans programme is 29 January 2026. The deadline for applications for best practice grants is 26 March 2026.

Engagement grants – National Archives

The Engagement Grants Programme offers grants of up to £3,000 for organisations to conduct outreach and engagement projects that will connect archives with their communities in places across England and Wales.

Engagement grants are often responsive to cultural events and days of national importance.

The theme for the current application round is 'Belonging'. The funder states: "By collecting records relating to our shared past and present, archives play an important role in helping people feel a sense of belonging."

The closing date for applications is 19 January 2026.

Social and Affordable Homes Programme 2026-35 – Homes England

The Social and Affordable Homes Programme 2026 to 2036 (SAHP) provides grant funding to support the capital costs of developing affordable housing in England (outside London).

The funding has 2 national strategic priorities. These are to maximise the delivery of:

- social and affordable homes, supporting the government's commitment to delivering 1.5 million homes in this parliament
- homes for Social Rent, with at least 60% of the total homes to be delivered as this tenure

SAHP also seeks to support an increase in:

- council housebuilding — directly from councils or in partnership with registered providers or developers
- the delivery of specialist and supported housing
- the delivery of community-led and rural housing

Partners will be expected to demonstrate how their bids will contribute to these priorities.

Established Mayoral Strategic Authorities can set the strategic direction of the SAHP in their areas.

Bids are welcomed from existing and new partners, including:

- not-for-profit registered providers
- for-profit registered providers
- local authorities
- housebuilders and developers
- charities
- community-led organisations

Jean Sainsbury Animal Welfare Trust grants

The objectives of JSAWT are to donate to UK registered charities whose purposes encompass one or more of the following:

- to benefit or protect animals
- to relieve animals from suffering
- to conserve wildlife
- to encourage the understanding of animals

There are three application deadlines each year for grants up to £10,000, open to charities registered in the UK – 1 April, 1 August and 1 December.

Urgent Capital Support – Department for Education

Urgent Capital Support is intended for academy trusts and Voluntary Aided (VA) schools, not in receipt of school condition allocation, and sixth-form colleges that want to apply for funding assistance to address urgent building condition issues that threaten the closure of the whole, or a significant part of the school. Applications are subject to a financial assessment, using the core financial returns shared with the Department for Education. For all academy applications, financial health is considered at academy trust level and not against the individual school. Please note that most successful applications will be funded through loan arrangements, where these are deemed affordable for the recipient.

The closing date for applications is 31 March 2026.

Valour Recognised Centres Development Fund – the Armed Forces Covenant Fund Trust

The VALOUR Recognised Centres (VRCs) Development Fund – funded by the Office for Veterans' Affairs within MOD – will award grants of up to £1m to provide veterans, and then the wider armed forces community, with in-person guidance and support.

Under this programme, the Armed Forces Covenant Fund Trust will administer grants to existing organisations or consortiums to provide a set of fixed services.

As a base service level, veterans should be able to access guidance and support in health, housing and employment. Applicants should also explain how they will offer guidance and support in other areas, ideally including, but not limited to, finance, wellbeing, welfare, integration into society, and other cross-cutting needs.

The fund is open to relevant charities, CICs and local government bodies. The deadline for applications is 14 January 2026.

Macmillan CARE grants – Macmillan Cancer Support

The CARE Grants Programme supports community organisations across the UK to tackle unfairness in cancer care. They want to fund projects that challenge the current system and create lasting change for people facing the greatest barriers to care.

Voluntary, community, faith or social enterprise (VCFSE) organisations can apply for between £50,000 and £150,000 under one of the following themes:

1. Cultural Responsiveness in Cancer Care

Projects that help healthcare services better understand and meet the cultural needs of different communities and remove barriers to person-centred care.

2. Shared Decision-Making

Projects that make it easier for people to understand their treatment options, take part in decisions about their cancer care, and reduce unfair differences in how this happens.

3. Dementia-Friendly Cancer Care

Projects that support people living with both cancer and dementia, improve their care experience, and help them and their carers take part in treatment decisions.

The deadline for applications is 23 January 2026.

Social housing innovation fund – Ministry of Housing, Communities and Local Government

This fund will provide grant funding to social landlords, tenant representative groups and other relevant organisations to test innovative projects which seek to improve tenant engagement with landlords and strengthen resident voice on matters that affect their homes. The resulting insights into best practice for achieving this will then be disseminated more widely across the sector to enable better outcomes for tenants.

Applicants can apply for up to £120,000. The indicative amount of funding per project will be between £60,000 and £120,000.

The deadline for applications is 9 January 2025.

Awards for All, and Reaching Communities – The National Lottery Community Fund (TNLCF)

Awards for All:

TNLCF offer funding from £300 to £20,000 and can support your project for up to two years. You can apply for funding to deliver a new or existing activity or to support your organisation to change and adapt to new and future challenges.

They can fund projects that'll do at least one of these things:

- bring people together to build strong relationships in and across communities
- improve the places and spaces that matter to communities
- help more people to reach their potential, by supporting them at the earliest possible stage
- support people, communities and organisations facing more demands and challenges because of the cost-of-living crisis.

Reaching Communities England:

With this funding, TNLCF want to help strengthen communities and improve lives across England. Their funding is available to all communities, but their priority is the places, people and communities that need it most.

When they say 'community', they mean people who live in the same area. Or people with similar interests or life experiences, even if they do not live in the same area.

They offer funding that starts at £20,001. Your project must help achieve one of these missions. Which are to support communities to:

- come together through inclusive places, spaces and activities (either physical or virtual), especially for communities where people are least able to come together
- help children and young people thrive by developing positive social and emotional skills
- be healthier by addressing health inequalities and helping prevent poor health
- be environmentally sustainable by engaging with climate issues, having a positive environmental impact, and improving access to quality natural spaces

National Lottery Awards for All England – Environment

This fund is available to community-led projects that improve the environment and help people connect with and enjoy nature where they live.

You can use the funding to:

- start a new activity or continue an existing one
- help your organisation adapt to new challenges
- run one-off events that have a clear environmental benefit.

They're looking to fund projects that:

- help people connect with and care for nature in their area
- make a positive difference to the environment

Funding from £300 up to £20,000 is available.

Digital Divide – The Access Foundation

The Access Foundation awards grants to support charities and CICs to mitigate the digital divide by making IT facilities, support and learning available to disadvantaged and vulnerable people.

They generally award grants between £10,000 and £50,000. This funding will normally support a project that lasts no more than a year. Applications are welcomed from a number of countries, including the UK.

Museum Fundamentals – Association of Independent Museums

The funder states: “Museums use their collections to tell stories and connect with visitors: to discover meaning behind objects and heritage, educate, entertain, inform and inspire. To do this they must know what is in their collection to see what stories they can tell and to have well-looked-after objects they can research, conserve, interpret and display. Museum Fundamentals will support small and medium sized museums with these core activities. Enabling them to care for collection’s more effectively and efficiently and to meet the standards required for Accreditation. Successful applicants will be given the opportunity to work with mentors, who can offer up to 2-3 days of support, to help guide and support them to deliver their project successfully.”

Up to £20,000 is available and the deadline for expressions of interest is 6 February 2026.

The Naturesave Trust

The funder states: “In 2022, the UK committed to protect at least 30% of land and sea for biodiversity by 2030 (30x30). Expanding and improving protected areas helps

nature recover and creates healthier places for people—clean air and water, resilient soils, beautiful green spaces, and greater climate resilience.

“Biodiversity underpins the processes that support all life on Earth. Without a wide range of animals, plants and microorganisms, we cannot have the healthy ecosystems we rely on for the air we breathe and the food we eat.”

They are inviting applications from charities, community groups, and organisations boosting biodiversity via:

- Pollinator plants
- Habitat restoration
- Hedgerow management
- Wildlife gardens
- Pesticide alternatives
- Conservation volunteering
- Education
- Influencing local councils
- Citizen science
- Community wildlife surveys

Grants up to £5000 are available via three funding windows per year (January to February, May to June, and September to October). The next round will open in January 2026.

Woodland Creation Planning Grants – Forestry Commission

The Woodland Creation Planning Grant (WCPG) offers funding of up to £30,500 for the production of a UKFS-compliant woodland creation design plan. Landowners, land managers and public bodies can apply. WCPG is open for applications year-round. 31 March 2027 is the period WCPG funding is currently confirmed until. You can apply for £1,500 to complete Stage 1 of the WCPG application. This is for a desk-based exercise to identify the constraints and opportunities affecting the proposed planting. If there's potential for woodland creation to take place on the site, then you will be offered a stage 2 payment.

Seed Corn Grants – The National Archives

Seed Corn Grants offer between £500 and £5,000 to support early-stage, exploratory projects that spark new ideas and approaches to community engagement with heritage.

These grants are designed for community groups, Galleries, Libraries, Archives, and Museums (GLAM) or other heritage organisations looking to test concepts, build partnerships, or pilot activities.

The next round of applications will open on 2 February and close on 17 April 2026.

Apart not Alone – Armed Forces Covenant Fund Trust

Under the Apart not Alone: Support for serving families facing service-related separation programme, the Armed Forces Covenant Fund Trust will award grants of between £5,000 and £50,000 for projects that mitigate the impact of service-related separation for families of serving personnel and reservists.

In addition, if you are a charity registered in the UK for at least three years, or a local authority, and you wish to provide targeted support for serving families facing challenges in specific locations in the UK due to service-related separation, you may wish to apply to the Apart, not Alone: Local impact grants programme. This programme will award portfolio grants up to £300,000 over three years.

The deadline for applications is 21 January 2026.

Solidarity Fund – The National Lottery Community Fund

This funding is for organisations in England dealing with the causes of inequality. By inequality they mean poverty, disadvantage and discrimination.

They'll fund organisations that are working on making a lasting change to the causes of inequality, and that support people who've lived through these issues to work together and influence this.

You do not need to be a long-established organisation to apply, but they'll expect you to have the ability to help make the kind of big and long-lasting changes they're looking for. They are unlikely to fund work that's completely unrelated to what you already do.

They are especially interested in work that builds on your knowledge, relationships, or things your community has learned – and that helps you take your work further or in a new direction.

You can apply for between £1 million and £5 million in total. You can spend this funding over 5 to 10 years.

Aviva Community Fund

Aviva will match each donation you receive through crowdfunding up to £250. This means that if someone gives £5, they'll double it to £10. If they give £250, they'll match it, so the cause gets £500. Organisations can receive up to £50,000 in match funding and eligible causes can apply at any time.

Aviva want to support forward-thinking causes that are helping to build stronger communities, and your project should align with one of the Aviva funding areas:

1. Financial Wellbeing: helping people take control of their wellbeing by giving them the tools to be more financially independent and ready for anything.
2. Climate Action: Promoting healthy, thriving communities by preventing, preparing for and protecting against the impacts of climate change.

Heritage Revival Fund – the Architectural Heritage Fund

The Heritage Revival Fund has been created to help communities across England rescue and repurpose neglected historic buildings. It will do this by supporting community organisations to take ownership of, adapt and reuse the local heritage assets that matter to them, transforming them into thriving spaces that meet their needs.

This new programme is being delivered by the Architectural Heritage Fund in partnership with the Department for Culture, Media and Sport (DCMS) and Historic England. Three types of grant are available:

- Project Viability Grants. These grants, up to £15,000, should help you to establish whether a project is viable. Work will probably focus on understanding the condition of the building, how it might be used, and whether that intended use is appropriate for the building and likely to be sustainable.
- Project Development Grants. These grants, up to £100,000, aim to support development work on historic building projects. Project Development Grants can contribute towards the costs of developing and co-ordinating your project and taking it towards the start of work on site. To qualify, an organisation must have established that the end use of the project is likely to be viable and have decided to take the project forward.

The next deadline for Project Development Grant applications is 19 January 2026.

NFU Mutual Charitable Trust grants

The objectives of Trust focus on the areas of agriculture, rural development and insurance in the UK and in particular:

- Advance the education of the public by means of research and dissemination of information in relation to agriculture
- Advance the education of young people within rural areas
- Relieve poverty within rural areas
- Promote the benefit and social welfare of inhabitants of rural communities by associating together with the inhabitants and local authorities, voluntary and other organisations to advance education and leisure
- Promote research into agriculture associated activities
- Advance the education of the public by means of research and dissemination of information in relation to insurance provided that the charity may also promote, facilitate and support any such other purposes as are exclusively charitable according to the laws of England and Wales

The Trust focuses on providing funding to larger initiatives, which would have a significant impact on the rural community. The Trustees are particularly interested in initiatives in the areas of education of young people in rural areas and relief of poverty within rural areas.

The Trustees meet twice a year to consider applications received. These meetings are currently held in June and November. The deadlines for 2026 grant applications will be displayed on the website. Most grants fall within the range £1000 to £50,000.

CLA Charitable Trust grants

The CLA Charitable Trusts seeks to support the most disadvantaged, and especially disadvantaged young people, to access the benefits of the countryside.

Their charitable objects are:

- Advancing people's physical and mental health and wellbeing through financial support of charities, not-for-profit organisations and social enterprises, which are delivering access, recreational and educational opportunities within and about the countryside.
- To promote and encourage education in sustainable farming, food production and rural land management.

They support a wide range of organisations providing activities engaging young people and communities in these areas. This include but are not limited to:

- Farms providing day or residential experiences for disabled or disadvantaged young people.
- Growing projects including horticultural therapy and community projects supporting people through outdoor activities and gardening.
- Forest school type activities giving people the opportunity to utilise their outdoor spaces for the benefit of their mental and physical wellbeing.
- Conservation and environmental projects giving people the chance to learn about the natural environment and how to care for it.

Grants up to £5000 are available.

Remediation Enforcement Support Fund – Ministry for Housing, Communities & Local Government

This funding is only available for Local Authorities and Fire and Rescue Authorities. The funding is for them to procure legal advice on pursuing those responsible for remediating buildings.

This funding is available as 2 options. The options are assessed and applied for separately. And a regulator does not need to have used option 1 funding before applying for option 2.

- Option 1 - £5,000 to procure independent advice from third party professionals to assess whether a legal case can be brought.
- Option 2 - Up to £100k to procure the necessary third-party expert services required to pursue the legal case.

The deadline for applications is 28 February 2026.

Sea-changers grants

Sea-Changers gives one-off grants (i.e. not continual funding) to UK-based charities and other organisations (including schools) carrying out marine conservation related activities.

For grants between £500 and £2,500, there are two grant rounds per year. Deadlines for applications are 31st March and 30th September each year.

Smaller grants up to £500 can be applied for at any time.

Access without limits grants – DofE

This fund is open for applications until January 2026. Grant funding of up to £10,250 is available for eligible community and voluntary organisations to set up and deliver the DofE, as well as the enrolment costs for young people taking part.

DofE not only offer grant funding but support organisations every step of the way.

This includes training for your staff and volunteers.

Farming in Protected Landscapes Programme – Department for Environment, Food & Rural Affairs

The Farming in Protected Landscapes programme is a part of Defra's Agricultural Transition Plan.

It will offer funding to farmers and land managers in National Landscapes (previously known as Areas of Outstanding Natural Beauty (AONBs)), National Parks and the Broads. It is not an agri-environment scheme.

The programme will fund projects that:

- support nature recovery
- mitigate the impacts of climate change
- provide opportunities for people to discover, enjoy and understand the landscape and its cultural heritage
- protect or improve the quality and character of the landscape or place

The Farming in Protected Landscapes programme has been developed by Defra with the support of National Landscape and National Park staff from across England.

This is a competitive programme which will now run until March 2026. Applications will close sooner if all funding is allocated.

Legal & General Health Equity Fund

This £3 million fund offers grants of up to £75,000 to place-based projects that address the social determinants of health: non-medical social and economic factors, such as housing, education, infrastructure, or quality of work.

The fund pilot initially launched and opened to receive expressions of interest to projects based in the North East of England. The opportunity is now open to receiving interest from organisations with projects or ideas for projects to be delivered in regions and communities UK-wide.

Example projects that may be supported include funding for inner-city schools in areas of deprivation to community programmes which address the social determinants behind pressures on A&E services, or partnerships raising awareness of the contribution the natural environment makes to health and wellbeing.

Energy Efficiency Sharematch – Crowdfunder

will support Co-operative Societies, Community Benefit Societies and Charitable Community Benefit Societies based in England to undertake activities which reduce their energy usage, or identify alternative sources of energy, leading to a reduction of both the organisation's carbon footprint and energy bills.

Eligible activities could include but are not limited to:

- Installation of new on-site energy/heating generation measures (eg solar panels, heat pumps)
- Installation of new energy efficiency measures in a building (eg insulation, LED lighting, double glazing, draft-proofing, improved doors)
- Improvements to other aspects of operations (e.g. changes to more energy efficient equipment, transport upgrade)

Energy Efficiency Sharematch is a £250,000 fund administered by Crowdfunder, working with Co-operatives UK and funded by Access – The Foundation for Social Investment using funds from the Dormant Assets Scheme, which redirects money from forgotten accounts to good causes.

The fund will run until March 2026, with the ambition to award all funds before this time.

IT4Good – WCIT Charity

The WCIT Charity is a national charity with a City of London home. Their purpose is to use the power of tech for impact through digital inclusion, education, charitable, and public engagement initiatives across the entire UK.

As an IT charity, all projects they fund must make use of information technology, and must relate to one or more of their priority areas

- Education
- Inclusion
- IT for charities
- Public understanding of IT

Projects need to demonstrate an innovative use of IT, be scalable for wider replication, and be sustainable over time.

Projects funded are usually up to £15,000.

Applications for funding may be submitted at any time and are considered at one of four meetings a year.

The Needs of Visually Impaired People – Ulverscroft Foundation

The Foundation gives financial help to Universities which carry out research into the causes and treatment of eye diseases. They also fund eye clinics, hospitals, schools, libraries and other organisations helping visually impaired people in the UK and overseas.

Applications for funding can be considered from any source, UK or overseas. Applicants need not necessarily be a charity: they can be a CIC or social group. Funding is at the discretion of the Trustees. Grants range from around £100 to £500,000.

Trustees meet quarterly to consider applications: in January (deadline 15 December), April (deadline 15 March), July (deadline 15 June) and October (deadline 15 September).

Stobart Sustainability Fund

The Stobart Sustainability fund is aimed at supporting community-led sustainability projects and initiatives led by non-profit organisations, community groups and educational facilities, such as schools and colleges, to help them transform their local community through projects that tackle climate change, reduce carbon emissions or that protect and enhance the environment.

They welcome applications from community groups, educational facilities or small businesses. Applications need to be of a green, ecological or sustainability nature with the project benefiting the environment.

Literacy small grants scheme – JJ Charitable Trust

The Trust seeks to improve the effectiveness of literacy teaching in primary and secondary education for children with learning difficulties, including dyslexia.

Their work has a particular focus on areas of social need and those who are at risk of non-inclusion in society and the world of work.

The Trust's small grants scheme funds charities and community groups that directly help children and young people develop literacy skills, with a focus on supporting those with learning difficulties such as dyslexia.

They are keen to see applications for projects that use volunteers and reading mentors and those that help during transitional points. For example, when students move from primary to secondary school, and when they transition to further education, college, or the workplace. They will consider grants for literacy support at any primary or secondary key stage.

You can apply for grants between £5,000 and £20,000. You can apply for a multi-year grant, over a maximum period of 3 years.

Their focus is to support projects that match their goal of getting more people active, reducing the number of inactive people and tackling inequalities.

Projects providing opportunities for groups facing barriers to activity are of particular interest, such as:

- people from culturally diverse communities
- pregnant women and parents with very young children
- girls aged 5-16

- LGBTQ+ people

Grant schemes for electric vehicle charging infrastructure – Office for Zero Emission Vehicles

The government offers grants to support the installation of electric vehicle chargepoints via the Office of Zero Emission Vehicles (OZEV). This includes:

- Electric vehicle chargepoint grant for renters and flat owners. You can get 75% off the cost to buy and install a socket, up to a maximum of £350.
- Electric Vehicle Chargepoint Grant for Households with On-Street Parking. You can get 75% off the cost to buy and install a socket, up to a maximum of £350.
- Electric vehicle infrastructure grant for staff and fleets. You can get up to £350 per chargepoint socket installed and up to £500 per parking space enabled with supporting infrastructure.
- Electric vehicle chargepoint and infrastructure grants for landlords. You can get 75% off the cost to buy and install a socket, up to a maximum of £350 per socket.
- Workplace charging scheme. The grant covers up to 75% of the total costs of the purchase and installation of EV chargepoints, capped at a maximum of £350 per socket and 40 sockets across all sites per applicant.
- Workplace Charging Scheme for state-funded education institutions. You can get 75% off the cost to buy and install chargepoints up to a maximum of: £2,500 per socket (40 sockets across all sites including any applications made previously via the Workplace Charging Scheme).

Historic Houses Foundation Grants

The Historic Houses Foundation gives grants for the repair and conservation of rural historic buildings and structures in England and Wales, including their gardens, grounds and outbuildings. Big Energy Saving Loans – Big Issue Invest

Big Issue Invest is offering loan finance between £20,000 to £200,000 to social enterprises and charities in England, for energy efficiency and renewable energy installation.

This lending programme is aimed at enabling social enterprises and charities to access loan funding to help save money on energy during the unprecedented cost of living crisis. Investment can be used for a variety of projects, including:

- Replacing old gas fired boiler systems with new efficient ones

Defibrillator grants – London Hearts

Grants are available to fund Public Access Defibrillators in communities all over the country.

London Hearts is a charity aiming to help and support communities with the provision of heart defibrillators and teaching CPR/defibrillator skills. They can provide a grant of £300 towards the cost of a defibrillator and storage as well as a free online training video.

When someone has a cardiac arrest, timely intervention is the key to survival. By making more defibrillators available, and by training more people to use them, the better the chance of survival for a cardiac arrest victim.

Biffa Award – Main Grant Scheme

Biffa Award's Main Grants Scheme is aimed at community and cultural groups and organisations, situated in the vicinity of landfill sites, that are in need of funding to improve the quality of life in their community or to conserve wildlife.

There are four themes - Community Buildings, Recreation, Cultural Facilities and Rebuilding Biodiversity. Under these themes we provide funding to create or improve community amenities. For example, upgrading kitchens, meeting rooms and toilets in village halls and community facilities; creating new playparks; installing new seating, lighting and exhibitions within theatres and museums; or establishing, protecting and enhancing habitats for biodiversity.

Between £10,000 and £75,000 can be awarded to projects that have a total cost of less than £200,000 including VAT.

Project sites must be within 5 miles of a significant Biffa Operation or active Biffa Landfill Site (15 miles for Rebuilding Biodiversity projects) and within 10 miles of any licenced landfill site in England and Northern Ireland.

This is a rolling programme and as such there are no deadlines to submit an Expression of Interest in the Main Grants Scheme.

Listed Places of Worship grant scheme – Department for Culture, Media and Sport

The Listed Places of Worship (LPW) Grant Scheme gives grants that cover the VAT incurred in making repairs to listed buildings in use as places of worship. The scheme covers repairs to the fabric of the building, along with associated professional fees, plus repairs to turret clocks, pews, bells and pipe organs.

The Scheme has been run by DCMS with a focus on preserving heritage in the fabric of UK listed places of worship. Since its establishment in 2001, the Scheme has adapted to changes while continuing to support places of worship by delivering the fairest possible system of making grants and ensuring that all faiths and areas of the UK are equally able to make use of scheme.

The scheme only accepts applications where the minimum value of eligible work carried out on any one claim to the scheme is £1,000 (excluding VAT). Places of worship can make more than one claim, but the total of their claims should not exceed £25,000.

The Government has confirmed funding is available for the Listed Places of Worship Grant Scheme until 31 March 2026. The programme will close earlier if all funds are allocated.

Masonic Charitable Foundation

The Foundation is dedicated to supporting disadvantaged children and young people, as well as vulnerable older people, in England and Wales. Their Charity Grants programme is open to registered charities in England and Wales working with any of their four main priority groups:

Large grants are for larger charities whose annual income is between £500,000 and £10 million. They must be restricted to a project. Large grants usually range from £10,000 to £60,000. They can be awarded over one to three years.

Forestry England Woodland Partnership

The Forestry England Woodland Partnership offers long-term leases with guaranteed income for public and private landowners to create new woodlands. The partnership scheme supports government plans for woodland creation, nature recovery and progress towards net zero targets.

Forestry England are looking for sites of at least 50 hectares suitable for woodland creation for leases of between 60 and 120 years, and landowners will receive a guaranteed annual rent throughout the lease period. Forestry England will design, plant and manage every woodland created, ensuring each is resilient to a changing climate, supports wildlife, and provides wider ecosystem services.

All woodlands created through the partnership scheme will be open to the public, providing valuable health and wellbeing opportunities for communities.

Part of the Nature for Climate Fund to support the government's tree planting commitment, the Forestry England Woodland Partnership aims to create at least 2,000 hectares of predominantly broadleaf woodland over the next five years.

Small, Medium and Large Grants – National Churches Trust

The National Churches Trust offer two types of grant:

- Medium grants - this programme offers grants of up to £10,000 towards urgent and essential maintenance and repair projects costing up to £80,000. Also project development and investigative work up to RIBA planning stage 1, to support churches preparing for a major project, and in developing their project to the point at which they can approach a major grant funder. Grants will never exceed 50% of the net project costs (for this phase). The next deadline for applications is 14 April 2026.
- Large grants – this programme offers grants up to £50,000 towards the cost of major urgent structural repair projects costed at more than £80,000 including VAT. Grants of £40,000 to £50,000 are extremely limited and reserved for cases which demonstrate a very high case for investment. They will also consider projects that introduce kitchens and accessible toilets to enable increased community use, costed at more than £30,000 including VAT. Grants

will never exceed 50% of the project cost. The next deadline for applications is 3 March 2026.

Energy Redress Scheme – Energy Saving Trust

Energy Saving Trust has been appointed by Ofgem to distribute payments from energy companies who may have breached rules. The funds can pay for anything from making a home more energy efficient, to providing advice that helps consumers keep on top of their bills.

Energy Saving Trust has developed an open application process for charities seeking funding from the Energy Redress Scheme. Successful projects will be selected with input from an independent panel of experts and could cover a range of locations across England, Scotland and Wales.

The amount of funding available through the scheme varies throughout the year and will be reviewed on a quarterly basis in October, January, April and July. Eligible charities that have registered interest in the scheme will be notified when funds become available.

The minimum grant that can be requested is £20,000 and the maximum amount is the lesser of £2 million or the total value of the current fund.

The scheme can fund projects lasting up to two years, can fund 100 per cent of the project cost and can cover revenue and capital measures.

Round 13 of the Energy Redress Scheme is expected to open shortly. The previous round included the following elements:

- The Main Fund aimed at projects seeking grants between £50,000 and £2 million that will support households in vulnerable situations.
- The Small Project Fund aimed at projects seeking grants of between £20,000 and £49,999 that will support households in vulnerable situations.
- The Impact Fund which supports more in-depth monitoring of measurable impact resulting from support to energy consumers in vulnerable situations. Applicants can apply for grants between £20,000 and £500,000.
- Innovation Fund aimed at projects that will develop innovative products or services to benefit households. Applicants can apply for grants between £20,000 and £1 million.
- Carbon Emissions Reduction Fund is targeted at projects that will reduce UK carbon emissions and empower households to reduce their carbon footprint. Applicants can apply for grants between £20,000 and £1 million.
- The Just Transition Fund will fund development work for community-led renewable energy projects that also benefit energy consumers in vulnerable situations. Applicants can apply for grants between £20,000 and £250,000.

Garfield Weston Foundation

The Foundation support a wide range of charities that make a positive difference, working in different sectors in the UK. These include welfare, youth, community, environment, education, health, arts, heritage and faith.

They fund small local organisations and large national institutions. Grants range from £1,000 to several million pounds, depending on each charity's size and scope of work.

The grants can be for your organisation's running costs, for a specific activity or for capital projects. The Foundation are flexible and fund what charities need the most.

Normally, capital grants are no more than 10% of a total project cost. However, for local community projects (e.g. village halls, community centres, places of worship, etc.), grants are unlikely to be over £30,000 regardless of the project size. If your organisation wants to apply for £100,000 or over, they expect your annual income or project to be over £1 million.

FCC Community Action Fund

The FCC Community Action Fund provides grants of between £10,000 and £100,000 to not-for-profit organisations for amenity projects eligible under Object D of the Landfill Communities Fund (LCF).

The following types of organisation can apply:

- Registered Charity which operates a community facility
- A Church or Parochial Church Council
- A Parish or Town Council or a Management Committee or User Association acting on behalf of a Parish or Town Council
- A Local Authority
- A CASC Registered Sports Club

Only applications for projects sited within 10 miles of an eligible FCC Environment waste facility can be accepted, you can check if you are located near an eligible site on their website.

The closing date for the next round of applications is 11 February 2026.

Gigabit Broadband Voucher Scheme – Department for Digital, Culture, Media & Sport

The Gigabit Broadband Voucher Scheme (GBVS) is part of Project Gigabit, the government's programme to roll out fast, reliable broadband to homes and businesses that are not included in suppliers' commercial plans.

The majority of Project Gigabit delivery will be through major contracts, providing subsidies to suppliers to extend their gigabit-capable networks to premises that are unlikely to be reached otherwise. The GBVS is focused on helping people upgrade their broadband connections through localised projects, providing small grants for residents and businesses that suppliers can accumulate towards the cost of the network build. The GBVS operates in areas where there is no Project Gigabit procurement or contract, or existing or planned commercial coverage.

Eligible homes and businesses can access vouchers worth up to £4,500 to help towards the costs of installing a gigabit-capable broadband connection.

Grants are normally awarded at 50% of eligible costs depending on the priority level of your project and are likely to be considered up to a maximum grant of £5,000 for non-freestanding war memorials while freestanding, non-beneficiary war memorials may be considered up to a maximum grant of £20,000. The minimum award is normally £125 but there is some discretion on minimum and maximum grant levels.

War Memorials Trust seeks to help all war memorial custodians, whatever the nature and size of their war memorial by facilitating repair and conservation projects. Details on current eligibility and deadline dates as well as how to apply can be found at the web address below.
