Farming in Protected Landscapes Programme – Department for Environment, Food & Rural Affairs

The Farming in Protected Landscapes programme is a part of Defra's Agricultural Transition Plan.

It will offer funding to farmers and land managers in National Landscapes (previously known as Areas of Outstanding Natural Beauty (AONBs)), National Parks and the Broads. It is not an agri-environment scheme.

The programme will fund projects that:

- support nature recovery
- mitigate the impacts of climate change
- provide opportunities for people to discover, enjoy and understand the landscape and its cultural heritage
- protect or improve the quality and character of the landscape or place

The Farming in Protected Landscapes programme has been developed by Defra with the support of National Landscape and National Park staff from across England.

This is a competitive programme which will now run until March 2026. Applications will close sooner if all funding is allocated.

Sea Changers Coastal Fountain Fund 2025

The purpose of the fund is to reduce the impact of single-use plastic water bottles on coastal habitats by funding communities to purchase water drinking fountains and install them for public use in busy or environmentally important areas.

Grants of up to £2,500 are available, per applicant, towards the cost of a fountain.

Applications are welcomed from all types of not-for-profit organisations who have identified a need and are well-placed to get the stakeholder involvement needed to make the project a success. They particularly welcome applications from Wales, Scotland, East Anglia and Northeast and Northwest England as these areas have been under-represented in previous years.

The closing date for applications is 25 April 2025.

Tackling Food Surplus at the Farm Gate – Department for Environment, Food & Rural Affairs

Food redistribution charities can now submit applications for a new £15 million Government scheme, which is helping to ensure surplus food is delivered to those who need it.

Government state: “Every year, an estimated 330,000 tonnes of edible food is either wasted or repurposed as animal feed before leaving farm gates. This food should be going onto the nation’s plates, but charities often lack the resources to salvage it and provide it to the most vulnerable.”

The new Tackling Food Surplus at the Farm Gate scheme aims to strengthen links between farms and charities to help solve the problem of food surplus on farms, with grants starting from £20,000 to help organisations fight hunger in communities.

Applicants can submit bids outlining how they intend to form relationships with farmers to access any surplus food, and how they would seek to increase their capacity to redistribute this food to communities.

The funding can go towards purchasing new packaging and labelling equipment and vehicles to move goods from farms to a redistribution organisation, as well as new equipment, like fridges or freezers, to safely store food and ensure it lasts longer.

The deadline for applications is 13 March 2025.

Charity Grants – The Arts Society

Applications are invited for projects across all aspects of the arts and heritage. The Society particularly encourage applications for projects that provide access to the arts to those that would not normally have access to them.

They encourage arts projects or programmes that support a wide range of activities to introduce people of all ages and backgrounds to and engage them in, artistic experience and practice. Projects and programmes that further the development and training of skills in the arts, crafts and heritage are welcome. We believe that people of all ages can benefit from acquiring and honing their creative and heritage skills. This might include bursaries for individual students, and sponsorship for craft apprentices.

They state: “The work of regional and local museums and galleries is important in connecting people with their local heritage and arts; yet these institutions often struggle to raise funds for projects and internships during times of budget cuts. Our grants may support special projects, displays, internship or part-time posts, training and conservation activities. We will also consider applications involving regional and local theatres and performing arts spaces and groups.”

They welcome applications where there will be more emphasis on localism and projects and organisations that support the arts and heritage at grass roots level and achieve greater impact for local communities.

Maximum grants of £2000 are available and the deadline for applications is 31 March 2025.

Dementia Grants Programme – McCarthy Stone Foundation

The Foundation will be awarding grants of up to £7,500 to over 20 dementia clubs and memory cafes across the country, all of which play a vital role in supporting people in their communities.

To apply you must be a registered charity, community group with constitution or Community Interest Company working in England, Scotland or Wales with a turnover

under £250,000 p.a. You should also be working in an area of deprivation affecting older people.

The deadline for applications is 14 March 2025.

Young Futures Fund – Asda Foundation

Young Futures Fund is a new funding opportunity, with grants ranging from £500 to £1,000, to be used to specifically support young people aged from 13-21.

Whether you're hosting a safe space for young people to be together or delivering workshops to educate 13-21 year olds on important topics such as knife crime, the Young Futures Fund can be used to deliver projects near you.

This grant is for groups which meet at least one of the following objectives:

- Provide services that support, educate and empower.
- Connect young people to their peers.
- Support rehabilitation and recovery and provide shelter.
- Deliver activities / programmes that improve physical health and wellbeing

The application window for this fund is open now until 13 March. Please note, the application window may close early if all funding is allocated.

Major Capital Grants Programme – Armed Forces Covenant Fund

This programme will award grants of between £75,000 and £500,000 towards projects that support significant refurbishment, including extensions and new builds, of rental accommodation that will offer high quality support for Veterans with a housing need.

To be eligible for this funding, you must be one of the following:

- A registered Charity that can show it works with Veterans, or
- A registered social housing provider or Registered Social Landlord in Scotland that can show it works with Veterans

Larger grants of between £500K to £1M may be available for exceptional projects which meet additional criteria as outlined in the programme guidance.

The deadline for applications is 18 June 2025.

Reducing Veteran Homelessness programme – Armed Forces Covenant Fund

Under this programme, the Armed Forces Covenant Fund Trust will award grants on behalf of the Office for Veterans' Affairs (OVA), towards projects that contribute to the aims of the government's ambition to reduce veteran homelessness and end rough sleeping.

This new round of the programme will provide funds to further improve the capacity of services in supported housing to meet the needs of vulnerable veterans.

Applications are invited from the following types of organisation:

- A registered charity which can demonstrate relevant experience and engagement in the direct provision of housing for veterans
- A registered social housing provider or registered social landlord in Scotland
- A local authority

You can apply for up to £300,000 per organisation towards a project being delivered over a period of up to nine months.

The deadline for applications is 31 March 2025.

Music for All is dedicated to changing lives across the UK by improving access to music making.

Established 28 years ago, Music for All has a track record in providing support. Over the past five years they have awarded over £300,000 in cash grants, donated hundreds of instruments and equipment to individuals, community groups and educational establishments, and provided free 'Learn to Play' experiences for thousands of people. The first funding round for 2025 is now open. Grants up to £2000 are available in a number of categories:

- Working with primary school aged children
- Working with diverse communities from the global majority
- Learning and cognitive challenges
- Guitars (electric)

Applications for individuals are also available. The deadline for applications is 27 March 2025.

Community Tree Planting Fund – Network Rail

The Tree Council and Network Rail work in partnership to deliver a programme of community tree planting. Together, they have already planted more than 300,000 trees in 108 communities across the UK.

Funding for projects is awarded in three bands:

- Main Grants - Projects between £2,500 and £5,000
- Large Grants - Projects between £5,000 and £10,000
- Flagship Grants - Projects over £10,000 and up to £15,000

Flagship Grants will be awarded in limited numbers to those projects that deliver a significant impact across our programme priorities.

Funding is now open and all details are on the website.

Green Heat Network Fund – Department for Energy Security & Net Zero

Capital grant support is available for the development of new and existing low and zero-carbon heat networks.

The Green Heat Network Fund (GHNF) supports:

- the commercialisation and construction of new low and zero carbon (LZC) heat networks (including the supply of cooling)
- the retrofitting and expansion of existing heat networks

It aims to develop and grow the heat network market and to address some of the challenges of decarbonising the UK's heat sector.

The fund is open to organisations in the public, private and third sectors in England. You can apply for funding that could be drawn down in financial years 2025-2026 through to 2027-2028. The deadline for applications is 11 April 2025.

Heat Network Efficiency Scheme – Department for Energy Security & Net Zero

The Heat Network Efficiency Scheme (HNES) provides funding to public, private and third sector applicants in England and Wales to support improvements to existing district heating or communal heating projects that are operating sub-optimally and resulting in poor outcomes for customers and operators.

It is a £80 million grant support programme spanning years 2023-2024 to 2027-2028. Applications for Round 9 are now open and will close on 28 March 2025.

Energy Efficiency Sharematch – Crowdfunder

will support Co-operative Societies, Community Benefit Societies and Charitable Community Benefit Societies based in England to undertake activities which reduce their energy usage, or identify alternative sources of energy, leading to a reduction of both the organisation's carbon footprint and energy bills.

Eligible activities could include but are not limited to:

- Installation of new on-site energy/heating generation measures (eg solar panels, heat pumps)
- Installation of new energy efficiency measures in a building (eg insulation, LED lighting, double glazing, draft-proofing, improved doors)
- Improvements to other aspects of operations (e.g. changes to more energy efficient equipment, transport upgrade)

Energy Efficiency Sharematch is a £250,000 fund administered by Crowdfunder, working with Co-operatives UK and funded by Access – The Foundation for Social Investment using funds from the Dormant Assets Scheme, which redirects money from forgotten accounts to good causes.

The fund will run until March 2026, with the ambition to award all funds before this time.

Healthy Heart Grants – Heart Research UK

Healthy Heart Grants of up to £15,000 are available for community projects aimed at supporting adults to reduce their risk of coronary heart disease, helping them to live healthier, happier and longer lives. The grants are available to charities and community interest companies across the UK.

The application windows for 2025 in England are:

- England North: 7 May to 4 June
- England South: 16 July to 13 August

Youth Music Trailblazer Fund

The Youth Music Trailblazer fund offers grants of £2,000 to £30,000 to organisations in England to run projects for children and young people (25 or under) to make, learn and earn in music. The project should trial work or test a new way of working, sustain a grassroots programme or disrupt the status quo (or all three!).

Your work must meet one of the Fund's themes:

- Early years
- Disabled, d/Deaf and neurodivergent young people
- Youth justice system
- Young people facing barriers
- Young adults
- Organisations and the workforce.

The deadline for applications is 11 April 2025.

Esmée Fairbairn Communities and Collections Fund

The Esmée Fairbairn Communities and Collections Fund supports work with museum collections to improve inclusion and equitable working with community partners. They offer:

- Core grants to museums that have established strategic aims for diversity, equity and inclusion (DEI); and that are ready to use their collections and our funding to support social and climate justice, in ways that are relevant to local contexts and relationships.
- Partnership project grants to museums and community organisations that work equitably together and share aims for DEI; with ambitious and compelling ideas for inclusive project work with collections.

The fund has a twin focus on inclusion and collections. They anticipate this will result in work that explores and influences key themes in social and climate justice, such as wellbeing, decolonisation, climate crisis, antiracism and others. Importantly, they will look for local relevance and holistic approaches from applicants, for example asking how you have decided who to work with.

Grants of up to £100k over a maximum of three years are available and they expect to award around 12 grants per year in two funding rounds. The deadline for second funding round is 16 July 2025.

IT4Good – WCIT Charity

The WCIT Charity is a national charity with a City of London home. Their purpose is to use the power of tech for impact through digital inclusion, education, charitable, and public engagement initiatives across the entire UK.

As an IT charity, all projects they fund must make use of information technology, and must relate to one or more of their priority areas

- Education
- Inclusion
- IT for charities
- Public understanding of IT

Projects need to demonstrate an innovative use of IT, be scalable for wider replication, and be sustainable over time.

Projects funded are usually up to £15,000.

Applications for funding may be submitted at any time and are considered at one of four meetings a year.

UK Under 26 Fund – Steel Charitable Trust

This fund aims to improve outcomes for children and young people in the UK (regardless of their nationality, culture or ethnic origin) who are wholly or mainly under 26 years of age. The overarching focus is on creating educational and/or access opportunities for young people in circumstances, groups or locations that face economic challenges or social marginalisation that may lead to significant disadvantages in later life.

Generally, £10,000 is the minimum grant size. Most one-off grants fall in the range £10,000 – £25,000.

The next deadline for applications is 15 April 2025 (this round opens on 10 March 2025).

CRASH is the construction industry's charity. CRASH assists homelessness charities and hospices with their refurbishment and construction projects, sourcing pro-bono or

discounted professional expertise, and construction products, from Corporate Patron companies and supporters within the industry.

They know buildings affect the way we feel and behave – even a small refurbishment project can make a big difference.

They work collaboratively with all of the homelessness and hospice charities they support to deliver assistance in three ways:

- Professional expertise.
- Construction products.
- Grant giving.

The Needs of Visually Impaired People – Ulverscroft Foundation

The Foundation gives financial help to Universities which carry out research into the causes and treatment of eye diseases. They also fund eye clinics, hospitals, schools, libraries and other organisations helping visually impaired people in the UK and overseas.

Applications for funding can be considered from any source, UK or overseas. Applicants need not necessarily be a charity: they can be a CIC or social group. Funding is at the discretion of the Trustees. Grants range from around £100 to £500,000.

Trustees meet quarterly to consider applications: in January (deadline 15 December), April (deadline 15 March), July (deadline 15 June) and October (deadline 15 September).

Awards for Social Entrepreneurs – UnLtd

Social entrepreneurs who have an idea or are already making a difference and are looking for support to develop their social venture can apply for funding and support to help get started or grow.

- Starting up grants up to £8000: You are committed to creating social impact in a financially sustainable way. You are at an early stage or have started to make a difference to people's lives, communities, or the planet.
- Scaling up grants up to £18,000: You are the founder of a financially sustainable social venture that is making a positive difference to people's lives, communities, or the planet. You have evidence of your social impact and ambitions to build on it.

The next deadline for applications is 24 March 2025.

Stobart Sustainability Fund

The Stobart Sustainability fund is aimed at supporting community-led sustainability projects and initiatives led by non-profit organisations, community groups and educational facilities, such as schools and colleges, to help them transform their local community through projects that tackle climate change, reduce carbon emissions or that protect and enhance the environment.

They welcome applications from community groups, educational facilities or small businesses. Applications need to be of a green, ecological or sustainability nature with the project benefiting the environment.

Literacy small grants scheme – JJ Charitable Trust

The Trust seeks to improve the effectiveness of literacy teaching in primary and secondary education for children with learning difficulties, including dyslexia.

Their work has a particular focus on areas of social need and those who are at risk of non-inclusion in society and the world of work.

The Trust's small grants scheme funds charities and community groups that directly help children and young people develop literacy skills, with a focus on supporting those with learning difficulties such as dyslexia.

They are keen to see applications for projects that use volunteers and reading mentors and those that help during transitional points. For example, when students move from primary to secondary school, and when they transition to further education, college, or the workplace. They will consider grants for literacy support at any primary or secondary key stage.

You can apply for grants between £5,000 and £20,000. You can apply for a multi-year grant, over a maximum period of 3 years.

The programme is open to applications at any time, but they make grants three times per year. These are the cut-off points for consideration of applications:

- Spring grant round: applications by 4 March
- Summer grant round: applications by 3 June
- Autumn grant round: applications by 1 October

Grants for historic church interiors and churchyard structures – Church of England

The Church of England give grants for the conservation of historic church interiors and churchyard structures in partnership with the Pilgrim Trust, the Radcliffe Trust, the Oswald Allen Bequest, the Worshipful Company of Goldsmiths, and the Anglican Parish Churches Fund. Grant categories are as follows:

- Bells and bell frames – grants up to £10,000, deadline for applications 31 March 2025.
- Books and manuscripts – grants up to £10,000, deadline for applications 19 June 2025.
- Church plate repairs – deadline for applications 9 June 2025.
- Churchyard structures – grants up to £10,000, deadline for applications 9 June 2025.
- Clocks – grants up to £10,000, deadline for applications 7 April 2025.
- Monumental brasses and decorative metalwork – grants up to £10,000, deadline for applications 9 June 2025.
- Monuments – grants up to £10,000, deadline for applications 9 June 2025.
- Organs – grants up to £10,000, deadline for applications 2 June 2025.
- Paintings and wall paintings – grants up to £10,000, see website for next application deadline.
- Stained glass – grants up to £10,000, deadline for applications 11 August 2025.
- Textiles – grants up to £8,000, deadline for applications 9 June 2025.
- Wooden objects – grants up to £10,000, deadline for applications 9 June 2025.

Community support small grants – Trusthouse Charitable Foundation

Single year grants between £2,000 and £10,000 are available to charities and not for profit organisations for core costs, salaries, running and project costs. Projects must have a focus on Community Support and address urban and rural deprivation in the UK.

if you are located in a rural area, you must be in the bottom 50% most deprived areas according to the Index of Multiple Deprivation. Your annual income must not exceed £250,000 and you can secure 50% of the total project costs.

This is a rolling programme with no deadlines.

Family support major and small grants – Trusthouse Charitable Foundation

Single year grants between £10,000 and £50,000 are available for core costs, salaries, running and project costs or multi-year grants for a maximum of 3 years, not to exceed £100,000 in total over this period, for core costs, salaries, running or project costs. No more than £50k can be applied for in any given year. Organisations should have a focus on Family Support, this may further include:

- Early intervention
- Families coping with addiction
- Prisoners' families

They fund voluntary sector organisations with a turnover up to £500,000.

Project Viability & Project Development Grants – the Architectural Heritage Fund

The Fund is offering grants of up to £15,000 to help assess the viability of historic building projects, and up to £20,000 towards development work to progress plans for historic buildings.

- Project Viability Grants: These grants should help you to establish whether a project is viable. Work will probably focus on understanding the condition of the building, how it might be used, and whether that intended use is appropriate for the building and likely to be sustainable.
- Project Development Grants: Project Development Grants can cover some of the costs of developing and co-ordinating your project and taking it towards the start of work on site. To qualify, an organisation must have established that the end use of the project is likely to be viable and have decided to take the project forward.

Applications are assessed at monthly grant decision meetings. This grant programme is supported by funding from Historic England.

Energy Resilience Fund – Power to Change

The Energy Resilience Fund is an initiative assisting community businesses in retrofitting their buildings with energy-saving measures. The programme is funded by Power to Change and delivered by Key Fund.

Investment amounts are available from £10,000 to £150,000. Up to 40% of the total is available as grant, where justifiable to support cost stabilisation or reduction. The minimum loan term for the remainder is 12 months, with a maximum of 7 years.

Energy Audit Grants are also available between £500 and £2,500 where these have not been completed.

Neighbourhood Planning Grant Funding – Locality

Government has confirmed the continued importance attached to supporting neighbourhood planning and on 1 October 2024 launched the procurement process for the new contract for Neighbourhood Planning Support Services for 2025 to 2027. Government intend to sign the new contract in April 2025 for the new services to open from July 2025.

The Movement Fund – Sport England

Launched in April 2024, the Movement Fund offers crowdfunding pledges, grants and resources to improve physical activity opportunities for the people and communities who need it the most.

If your project aligns with Sport England priorities, they can fund a wide range of costs and items up to £15,000.

Their focus is to support projects that match their goal of getting more people active, reducing the number of inactive people and tackling inequalities.

Projects providing opportunities for groups facing barriers to activity are of particular interest, such as:

- people living on low incomes
- disabled people or those with long-term health conditions
- older people
- people from culturally diverse communities
- pregnant women and parents with very young children
- girls aged 5-16
- LGBTQ+ people
- people who are in foster care
- people who provide care without pay.

Electricals Recycling Fund – Material Focus

The Electricals Recycling Fund aims to grow existing methods or test new creative and practical ones for recycling small household electricals. If you have a project that would make it easier for the public to repair, reuse or recycle their electricals, you can apply for funding.

They fund two types of projects – those seeking to grow or develop existing household collection services for small household electricals, and those seeking to innovate new collection methods.

- Organisations can apply for up to £100,000 of funding for projects that aim to grow or improve existing household waste and recycling collection services.
- Organisations can apply for up to £50,000 for projects that aim to innovate or test new approaches to collect electricals for reuse and recycling.

They're keen to see applications from registered organisations only – such as local authorities, waste collection authority areas, contractors, non-profits, community sector organisations, producer compliance schemes, and retailers.

Applications are currently open on a rolling basis.

Climate Action Fund: Our Shared Future – The National Lottery Community Fund

The Climate Action Fund is a commitment to help communities tackle climate change. The Fund is supporting communities to be environmentally sustainable.

With Climate Action Fund – Our Shared Future, Lottery want to involve more people in climate action. They we want to inspire bold and exciting change.

They'll fund formal partnership projects that reach more people by either:

- linking climate action to the everyday lives and interests of local communities. And inspiring them to take action.
- influencing communities at a regional or national level. Like linking up groups across locations. Or a campaign that inspires change across one country, or the whole UK.

Formal partnerships can apply, working across sectors and led by community and voluntary organisations or public sector organisations.

The minimum you can ask for is £500,000. They expect to fund most projects for between £1 million and £1.5 million over 3 to 5 years and aim to fund up to 25 projects. You'll be able to apply until Spring 2025. They will announce the final deadline nearer the time.

The UK Fund – The National Lottery Community Fund

The UK Fund is looking to fund organisations that want to do more to help communities come together and help make us a better-connected society.

Your project must either work across the UK, or be able to inform, influence or scale across the UK.

They want to fund projects that:

- strengthen relationships between people whose experiences of life have not been the same. For example, relationships between people of different ethnic backgrounds, generations, occupations or geographies
- create connections between online and offline worlds
- help make sure people from all backgrounds can shape the future of their communities.

£500,000 to £5m is available and they expect most projects to run from 2 to 5 years. They may consider funding for up to 10 years.

Grant schemes for electric vehicle charging infrastructure – Office for Zero Emission Vehicles

The government offers grants to support the installation of electric vehicle chargepoints via the Office of Zero Emission Vehicles (OZEV). This includes:

- Electric vehicle chargepoint grant for renters and flat owners. You can get 75% off the cost to buy and install a socket, up to a maximum of £350.
- Electric Vehicle Chargepoint Grant for Households with On-Street Parking. You can get 75% off the cost to buy and install a socket, up to a maximum of £350.
- Electric vehicle infrastructure grant for staff and fleets. You can get up to £350 per chargepoint socket installed and up to £500 per parking space enabled with supporting infrastructure.
- Electric vehicle chargepoint and infrastructure grants for landlords. You can get 75% off the cost to buy and install a socket, up to a maximum of £350 per socket.
- Workplace charging scheme. The grant covers up to 75% of the total costs of the purchase and installation of EV chargepoints, capped at a maximum of £350 per socket and 40 sockets across all sites per applicant.
- Workplace Charging Scheme for state-funded education institutions. You can get 75% off the cost to buy and install chargepoints up to a maximum of: £2,500 per socket (40 sockets across all sites including any applications made previously via the Workplace Charging Scheme).

D'Oyly Carte Charitable Trust grants

The D'Oyly Carte Charitable Trust funds United Kingdom Registered Charities operating in the UK in the fields of the advancement of the arts, health and medical welfare and environmental protection or improvement.

The Trust makes grants which are usually in the range £500 - £6,000 and there are three grant-making meetings held annually which take place in March, July, and November. The majority of the Trust's grants are single grants over a one-year period. The next deadline for applications is 3 June 2025.

Suez Communities Fund

The SUEZ Communities Fund in England has approximately £1.6M available per year, funded by donations from SUEZ Recycling and Recovery UK, through the Landfill Communities Fund.

To be eligible for a grant, your project must be located within one of their active funding zones. A postcode checker is available on their website.

Grants between £3,000 and £50,000 are available for community projects delivering capital improvements to public amenities. Examples may include:

- Village hall improvements
- Nature reserves and conservation
- Village greens
- Community centres
- Public playgrounds
- Cycle paths
- Sports fields and facilities
- Country parks
- Historic buildings, structures or sites

There are four deadlines for applications, each year. The next deadline is 14 May 2025.

Historic Houses Foundation Grants

The Historic Houses Foundation gives grants for the repair and conservation of rural historic buildings and structures in England and Wales, including their gardens, grounds and outbuildings. We also give grants for the restoration and conservation of works of art in historic house collections open to the public.

Grants are made to owners (charities, institutions, local authorities and individuals) who demonstrate a sustainable and long-term commitment to the care, management and public access of the historic country houses in their care.

The minimum Historic Houses Foundation grant is £1,000 and the maximum is £250,000 but an award of this size is only made under exceptional circumstances. Most grants are for less than £50,000.

Community and Environmental Grants – Veolia Environmental Trust

The Trust award grants towards projects that make improvements to community facilities and the natural environment.

The Trust's Community Grant Scheme is available to constituted not-for-profit organisations, local authorities and Environmental Bodies (EBs). Grants of between £10,000 and £75,000 are available to create or improve buildings or outside spaces for the benefit of the community.

The Habitat and Biodiversity Grant Scheme offers grants between £10,000 and £75,000 whilst the Environmental Improvement Grant Scheme offers grants over £75,000. Nature Conservation grants are also available.

The next funding round closes on 3 April 2025.

The Rowing Foundation

The Rowing Foundation purpose is to promote the participation in rowing of young people (those under 18 or still in full time education) and the disabled of all ages. They provide grants towards the cost of boat equipment or boat refurbishments to support junior & student rowers, and adaptive rowing for all ages.

They match your spending up to a maximum of £4,000 per grant.

The Trustees meet three times per year to consider applications for equipment grants.

The deadline for the next round is 17 March 2025.

Refurbishment Grants are awarded on an ongoing basis throughout the year.

Open Grants Programme – The Clothworkers' Foundation

The Foundation award grants to UK registered charities, CICs, and other registered UK not-for-profit organisations (including special schools). Grants are awarded towards capital projects, which they define as:

- Buildings: purchase, construction, renovation or refurbishment.
- Fittings, Fixtures, and Equipment: this includes but is not limited to office equipment/furniture, sports/gym equipment, digital/audio visual equipment, software and websites (more guidance on digital infrastructure can be found here), garden equipment, specialist therapeutic (excluding medical) equipment. It does not include equipment for one-off use, or which will be given to service users for personal use on a permanent basis.
- Vehicles: This includes a minibus, car, caravan, people-carrier, or 4X4. We are unlikely to fund the total cost of a new vehicle and do not provide grants towards vehicle leasing.

They fund both large and small projects.

They offer three levels of grants. These are large grants of £20,000 and above; medium grants of up to £20,000 and small grants of £5,000 and under. Grants can be used for:

- Capital projects which include new buildings, extensions, refurbishments and recreational spaces.
- New minibuses and other vehicles that provide a vital service to those most in need in their local community.
- Churches and other places of worship with a strong, secular community focus.
- Charities or CIOs (Charitable Incorporated Organisations) registered in England and Wales.
- Certain organisations with exempt status such as specialist schools, scout and guide groups, housing associations, cooperatives, and community benefit societies.

Applications are accepted all year round.

Building Improvement Grants – Benefact Trust

Benefact Trust's Building Improvement Grants programme provides essential support to protect and enhance churches and Christian charity buildings, ensuring their continued use, viability, and the safeguarding of their heritage.

The programme is open to applications from churches, cathedrals, denominational bodies and Christian charities.

Under Building Improvement Grants, they are able to support direct capital costs relating to the following types of work:

- Essential, one-off repairs or other capital works to ensure the continued use or viability of a building (capital work must be considered urgent or necessary within 12 months)
- Minor capital works or equipment purchases to meet operational or accessibility requirements (e.g. essential operational equipment, AV equipment, hearing loops, ramps, etc)
- Conservation or restoration of historic features (e.g. stained glass, carvings, interior furnishings, clocks, tower bells, organs etc) which contribute to preservation and appreciation of a building's heritage
- Other aesthetic enhancements (e.g. interior decoration, furnishings or public realm improvements) to improve indoor or outdoor spaces for users
- Energy efficiency/renewable energy measures (e.g. heating/lighting upgrades, solar panels, etc) which improve the sustainability of church buildings/facilities and enable their continued use

All applicants will be expected to have secured funding for at least 30% of their total project costs before making an application.

Small grants programme – Theatres Trust

Theatres Trust's Small Grants Programme, supported by The Linbury Trust, funds small projects that make a big impact to a theatre's resilience, sustainability, accessibility or improving the diversity of audiences.

This scheme provides grants of up to £5,000 for essential works to enable not-for-profit theatres across the UK to be viable and thrive in the future.

Eligible projects include small capital works, the installation of key plant and machinery and works which make theatre buildings digital-ready.

This scheme will prioritise improvements to buildings that protect theatre use and remove barriers to participation and attendance.

The programme is expected to re-open to applications soon.

Big Energy Saving Loans – Big Issue Invest

Big Issue Invest is offering loan finance between £20,000 to £200,000 to social enterprises and charities in England, for energy efficiency and renewable energy installation.

This lending programme is aimed at enabling social enterprises and charities to access loan funding to help save money on energy during the unprecedented cost of living crisis. Investment can be used for a variety of projects, including:

- Insulation
- Buying and installing renewable energy equipment
- Heat exchangers and heat pumps
- LED light installations
- Replacing old gas fired boiler systems with new efficient ones
- Property improvements, such as extra single glazing on existing windows, double glazing improvements, systematic draught improvements
- Energy efficiency survey and technical assistance costs

The loans can be structured to your individual needs. They can be unsecured which means they will not require you to put any personal guarantees in place, or interfere with other financing arrangements that require security.

Project Cost and Core Cost grants – BBC Children in Need

Children in Need often have several funding programmes open at any one time.

These include:

- Project Costs grants – support the aims and delivery of a specific piece of work. This work will usually be time-limited and based on a defined set of activities.
- Core Costs grants – can be spent on an organisation's central running and operational costs.

Charities and not-for-profit organisations can apply for these grants for up to three years. They aim to give quicker decisions for grants of £15,000 or less per year.

The programme provides items that meet a child's most basic needs such as a bed to sleep in, a cooker to provide a hot meal and other items or services critical to a child's wellbeing.

All applications must be made by a registered referrer.

Defibrillator grants – London Hearts

Grants are available to fund Public Access Defibrillators in communities all over the country.

London Hearts is a charity aiming to help and support communities with the provision of heart defibrillators and teaching CPR/defibrillator skills. They can provide a grant of £300 towards the cost of a defibrillator and storage as well as a free online training video.

When someone has a cardiac arrest, timely intervention is the key to survival. By making more defibrillators available, and by training more people to use them, the better the chance of survival for a cardiac arrest victim.

Biffa Award – Main Grant Scheme

Biffa Award's Main Grants Scheme is aimed at community and cultural groups and organisations, situated in the vicinity of landfill sites, that are in need of funding to improve the quality of life in their community or to conserve wildlife.

There are four themes - Community Buildings, Recreation, Cultural Facilities and Rebuilding Biodiversity. Under these themes we provide funding to create or improve community amenities. For example, upgrading kitchens, meeting rooms and toilets in village halls and community facilities; creating new playparks; installing new seating, lighting and exhibitions within theatres and museums; or establishing, protecting and enhancing habitats for biodiversity.

Between £10,000 and £75,000 can be awarded to projects that have a total cost of less than £200,000 including VAT.

Project sites must be within 5 miles of a significant Biffa Operation or active Biffa Landfill Site (15 miles for Rebuilding Biodiversity projects) and within 10 miles of any licenced landfill site in England and Northern Ireland.

This is a rolling programme and as such there are no deadlines to submit an Expression of Interest in the Main Grants Scheme.

Listed Places of Worship grant scheme – Department for Culture, Media and Sport

The Listed Places of Worship (LPW) Grant Scheme gives grants that cover the VAT incurred in making repairs to listed buildings in use as places of worship. The scheme covers repairs to the fabric of the building, along with associated professional fees, plus repairs to turret clocks, pews, bells and pipe organs.

The Scheme has been run by DCMS with a focus on preserving heritage in the fabric of UK listed places of worship. Since its establishment in 2001, the Scheme has adapted to changes while continuing to support places of worship by delivering the fairest possible system of making grants and ensuring that all faiths and areas of the UK are equally able to make use of scheme.

The scheme only accepts applications where the minimum value of eligible work carried out on any one claim to the scheme is £1,000 (excluding VAT). Places of worship can make more than one claim, but the total of their claims should not exceed £25,000.

The Government has confirmed funding is available for the Listed Places of Worship Grant Scheme until 31 March 2026.

Masonic Charitable Foundation

The Foundation is dedicated to supporting disadvantaged children and young people, as well as vulnerable older people, in England and Wales. Their Charity Grants programme is open to registered charities in England and Wales working with any of their four main priority groups:

- Improving the health and wellbeing of older people with dementia and their carers.
- Children affected by domestic abuse.
- Early years (0-5) with a focus on poverty and neglect.
- Children with special educational needs and disabilities.

Small grants are for charities whose annual income is between £25,000 and £500,000. These grants are unrestricted. Small grants range from £1,000-£5,000 per year, for up to three years.

Large grants are for larger charities whose annual income is between £500,000 and £10 million. They must be restricted to a project. Large grants usually range from £10,000 to £60,000. They can be awarded over one to three years.

Community Shares Booster – Power to Change

The Booster Fund has relaunched to support new and existing community businesses in England that are at all stages of a community share issue.

This includes the very early stages of exploring whether it's the right choice, through planning a community share issue to being ready to launch, or in exceptional cases, recently launched.

The programme provides:

- Development grants averaging £5,000 to prepare a community share offer; financial planning, governance support, marketing costs and being awarded the Community Shares Standard Mark
- Match equity investment – typically matching pound for pound up to £25,000 invested by the Booster Fund providing the minimum share offer target is achieved

Forestry England Woodland Partnership

The Forestry England Woodland Partnership offers long-term leases with guaranteed income for public and private landowners to create new woodlands. The partnership scheme supports government plans for woodland creation, nature recovery and progress towards net zero targets.

Forestry England are looking for sites of at least 50 hectares suitable for woodland creation for leases of between 60 and 120 years, and landowners will receive a guaranteed annual rent throughout the lease period. Forestry England will design, plant and manage every woodland created, ensuring each is resilient to a changing climate, supports wildlife, and provides wider ecosystem services.

All woodlands created through the partnership scheme will be open to the public, providing valuable health and wellbeing opportunities for communities.

Part of the Nature for Climate Fund to support the government's tree planting commitment, the Forestry England Woodland Partnership aims to create at least 2,000 hectares of predominantly broadleaf woodland over the next five years.

Small, Medium and Large Grants – National Churches Trust

The National Churches Trust is making changes to its grants programme.

They will continue to offer three types of grant. These will be:

- Small grants - these were formerly called Foundation grants for maintenance. This programme offers grants of between £500 and £5,000 towards urgent maintenance works and small repairs identified as high priority within a recent Quinquennial Inspection or Survey Report. Also, small investigative works and surveys. Project costs should be up to £20,000 incl. VAT and awards will never exceed 50% of the costs. See website for the next deadline for applications.
- Medium grants - these were formerly called Gateway grants. This programme offers grants up to £10,000 towards urgent and essential maintenance and repair projects costing between £20,000 and £80,000. Also project development and investigative work up to RIBA planning stage 1, to support churches preparing for a major project, and in developing their project to the point at which they can approach a major grant funder. Grants will never exceed 50% of the net project costs (for this phase). The next deadline for applications is 15 April 2025.
- Large grants – these were formerly called Cornerstone grants. This programme offers grants up to £50,000 towards the cost of major urgent structural repair projects costed at more than £80,000 including VAT. Grants of £40,000 to £50,000 are extremely limited and reserved for cases which demonstrate a very high case for investment. They will also consider projects that introduce kitchens and accessible toilets to enable increased community use, costed at more than £30,000 including VAT. Grants will never exceed 50% of the project cost. See the website for the next deadline for applications.

Energy Redress Scheme – Energy Saving Trust

Energy Saving Trust has been appointed by Ofgem to distribute payments from energy companies who may have breached rules. The funds can pay for anything from making a home more energy efficient, to providing advice that helps consumers keep on top of their bills.

Energy Saving Trust has developed an open application process for charities seeking funding from the Energy Redress Scheme. Successful projects will be selected with input from an independent panel of experts and could cover a range of locations across England, Scotland and Wales.

The amount of funding available through the scheme varies throughout the year and will be reviewed on a quarterly basis in October, January, April and July. Eligible charities that have registered interest in the scheme will be notified when funds become available.

The minimum grant that can be requested is £20,000 and the maximum amount is the lesser of £2 million or the total value of the current fund.

The scheme can fund projects lasting up to two years, can fund 100 per cent of the project cost and can cover revenue and capital measures.

Round 13 of the Energy Redress Scheme is expected to open shortly. The previous round included the following elements:

- The Main Fund aimed at projects seeking grants between £50,000 and £2 million that will support households in vulnerable situations.
- The Small Project Fund aimed at projects seeking grants of between £20,000 and £49,999 that will support households in vulnerable situations.
- Innovation Fund aimed at projects that will develop innovative products or services to benefit households. Applicants can apply for grants between £20,000 and £1 million.

- Carbon Emissions Reduction Fund is targeted at projects that will reduce UK carbon emissions and empower households to reduce their carbon footprint. Applicants can apply for grants between £20,000 and £1 million.
- The Just Transition Fund will fund development work for community-led renewable energy projects that also benefit energy consumers in vulnerable situations. Applicants can apply for grants between £20,000 and £250,000.

Garfield Weston Foundation

The Foundation support a wide range of charities that make a positive difference, working in different sectors in the UK. These include welfare, youth, community, environment, education, health, arts, heritage and faith.

They fund small local organisations and large national institutions. Grants range from £1,000 to several million pounds, depending on each charity's size and scope of work. The grants can be for your organisation's running costs, for a specific activity or for capital projects. The Foundation are flexible and fund what charities need the most.

Normally, capital grants are no more than 10% of a total project cost. However, for local community projects (e.g. village halls, community centres, places of worship, etc.), grants are unlikely to be over £30,000 regardless of the project size. If your organisation wants to apply for £100,000 or over, they expect your annual income or project to be over £1 million.

FCC Community Action Fund

The FCC Community Action Fund provides grants of between £2,000 and £100,000 to not-for-profit organisations for amenity projects eligible under Object D of the Landfill Communities Fund (LCF).

The following types of organisation can apply:

- Registered Charity which operates a community facility
- A Church or Parochial Church Council
- A Parish or Town Council or a Management Committee or User Association acting on behalf of a Parish or Town Council
- A Local Authority
- A CASC Registered Sports Club

Only applications for projects sited within 10 miles of an eligible FCC Environment waste facility can be accepted, you can check if you are located near an eligible site on their website.

The closing date for the next round of applications is 14 May 2025.

Gigabit Broadband Voucher Scheme – Department for Digital, Culture, Media & Sport

Project Gigabit is the government's £5 billion programme that targets hard-to-reach areas where it is more difficult and more expensive to build digital infrastructure. The majority of the rollout will come through local and regional contracts, providing subsidies to suppliers to extend their gigabit-capable networks to premises that are unlikely to be reached otherwise.

The Gigabit Broadband Voucher Scheme (GBVS) is part of Project Gigabit, focused on helping specific people and communities upgrade their broadband connection. It mainly operates in areas where there is no existing coverage, planned commercial coverage or through Project Gigabit procurements.

Eligible homes and businesses can apply for up to £4,500 to cover the costs of a gigabit-capable connection.

Awards for All, Reaching Communities and Partnerships – The National Lottery Community Fund (TNLCF)

Awards for All:

TNLCF can fund projects or organisations that'll do at least one of these things:

- bring people together to build strong relationships in and across communities
- improve the places and spaces that matter to communities
- help more people to reach their potential, by supporting them at the earliest possible stage.

Partnerships:

This funding is for organisations working together in partnership to help their community. This funding also starts at £20,001 and can fund projects that do at least one of the things also specified under the Reaching Communities programme.

War Memorials Trust grants support repair and conservation works undertaken following best conservation practice. Almost all war memorials are eligible for support and custodians/owners can find information about eligibility and processes on the website.

Grants are normally awarded at 50% of eligible costs depending on the priority level of your project and are likely to be considered up to a maximum grant of £5,000 for non-freestanding war memorials while freestanding, non-beneficiary war memorials may be considered up to a maximum grant of £20,000. The minimum award is normally £125 but there is some discretion on minimum and maximum grant levels.

War Memorials Trust seeks to help all war memorial custodians, whatever the nature and size of their war memorial by facilitating repair and conservation projects. Details on current eligibility and deadline dates as well as how to apply can be found at the web address below.
