UK Community Renewal Fund





- £220m fund aimed at supporting communities to **pilot** programmes, including to promote community resilience and new approaches to support both business and people ahead of the UK Shared Prosperity Fund (SPF).
- Focus on supporting innovative responses to local challenges and local need across the UK, spanning urban, rural
 and coastal areas.
- A competitive revenue support programme, but with no ringfencing of funds between themes and no requirement for match funding.
- Four investment areas prioritised by Government:
 - **Supporting Investment in Skills** with an emphasis on facilitating work-based training, upskilling and retraining of the workforce, and promotion of digital skills and digital inclusion.
 - **Supporting People into Employment** with an emphasis upon supporting individuals to access local services / provision into employment, identifying and addressing barriers to employment amongst the hardest to reach, raising local aspiration and supporting individuals to find sustainable employment, and seeking to support additional basic skills provision.
 - **Supporting Investment in Local Businesses** with an emphasis on supporting new entrepreneurs and business to taker on new employees and promote existing staff, development new products and services through innovation, and support local decarbonisation measures.
 - Supporting Investment in Communities and Places Enabling feasibility studies to deliver local carbon and energy projects, exploring opportunities for cultural led / community led regeneration activity, improving green spaces and preserving local assets, and promoting rural connectivity.
- Devon introduced fifth local emphasis on *reducing economic and social inequalities*, with a focus on harder to reach people and communities.

UK Community Renewal Fund







- Up to £3m available per 'place' (District), meaning Devon could bid for up to £24m in total.
- 100 priority places identified nationwide for the fund with a weighting towards rural deprivation and peripherality.
- Torridge and West Devon prioritised in Devon. Did not preclude other areas from bidding, or cross area bids, but reduced scoring if not a priority place.
- Upper tier authorities asked to act as accountable bodies for both collation and appraisal of local bids, and then to act as managing authority for any funds awarded.

UK Community Renewal Fund **Devon CRF**





Devon County Council has been awarded £9.3m, the largest funding allocation in the UK for a single area, including £5m for priority areas.

Supported 13 innovative projects across Devon:

- employment and training
- business and social enterprise support
- environmental initiatives
- community resilience

UK Community Renewal Fund **Our approach**





- From the Application stage, the DCC CRF team worked closely with the potential bidders to help them identify the best projects for the area and to build sustainable partnerships in a very limited period of time
- DCC acknowledged that CRF was designed as a pilot, therefore we are allowing projects to make delivery changes where necessary. The CRF team adopted an agile approach in the implementation stage and worked closely with all the projects to address their needs accordingly.
- Projects submit monthly written progress reports with risk updates and meet with the DCC CRF team
 regularly for progress reviews. This allows for project status updates and consideration of mitigation
 actions where necessary.
- DCC organised occasional full meetings where all the project deliverers asked questions in front of the whole programme and can cross fertilise ideas and knowledge.
- DCC developed a robust management plan with clear responsibilities, deadlines, and controls in place to correctly identify and reimburse eligible expenditure

UK Community Renewal Fund Lessons learned





- Rurality and peripherality were key selection factors in this programme. Not clear yet whether that will happen again.
- Our focus on Green / Blue and Community Inclusion closely aligned with Government's emerging focus for Levelling Up. Government less interested in standard regeneration activity.
- Some smaller organisations were not able to bid due to tight timescales and the minimum £500,000 threshold too much of a challenge and a risk for organisations with limited capacity.
- Significant resource was required at Devon CC to manage the application process and enable project contracting in short timescales
- Issues with outputs definitions and contracting delays made for a very slow start
- The delivery extension offered by government was helpful, although a 1 year pilot scheme from the start would be preferred
- Most projects applied for a six months extension without requiring any additional funding a clear indication that the forecasted project budgets were overestimated to cover the projects' risks (triggered by the very short implementation period)

UK Community Renewal Fund Devon CRF achievement





Over the last 11 months (up to October 2022) Devon CRF supported:

- more than 3,800 individuals to enter new training opportunities
- more than 600 businesses and 800 organisations (public, private, voluntary sector)
- more than 100 people into in employment (including self- employment and employment increase in supported businesses)

Devon CRF also attracted £470,000 investment in Devon as a result of support

CRF runs until December 2022 so final numbers will be higher







Promoting Innovation and Enterprise

Petroc College









Project Breakdown:

- The project had four elements:
- Farm Innovation Pilot develop a 'Farm Innovation Plan' process and test with farm businesses in West Devon and Torridge. This element by Duchy College Rural Business School and Business Information Point.
- Knowledge Exchange and Voucher Scheme pilot A Knowledge Exchange Manager will work with 14 businesses across Devon to identify bespoke support, advice or services needed to develop Agricultural technology and innovation or grow your business.
- Research & Mapping Understanding how many farms currently utilise technology, what opportunities may be around the corner and what Agri-Tech developers we have within Devon. The research element ran by the University of Plymouth.
- Building an Agri-Tech Alliance Create a group for farmers, Agri-Tech developers and stakeholders like academic institutions who are undertaking research. This will use the research and mapping to plan how to grow and support the sector in the future.



UK Community Renewal Fund Where are we now?





- Project delivery completing by 30th Nov 22; Managing Authority financial completion Jan 2023
- Evaluations in progress one per project. Government to carry out overall programme evaluation.
- So more CRF lessons learned and case study information to follow
- UK SPF is being delivered differently in 2 Tier areas allocated to 8 individual districts, all awaiting decisions on investment plans
- DevonCC coordination/collaboration role
- Investment Zones DevonCC coordination/submission role pipeline!
- Rural England Prosperity Fund individual districts bids, capital only linked to UK
 SPF
- Levelling Up Fund district schemes and County transport scheme some good joint working
