





What is the Digest?

What is the Digest?

- **Supplementary data tables**; these have no text but instead focus on the statistics themselves, often providing them in more detail than what is given in the PDF report
- We are also working to develop **web versions** (HTML) of the publication to improve accessibility.

How do we choose?

The Digest covers a wide variety of topics. Our decisions for analysing data are usually informed by:

- Stakeholder interest and priorities
- Ministerial interest and priorities
- **Policy** interest and priorities

Why did it need updating?

Previously, there were issues with the way we presented the Digest:

- 1) It was one <u>big</u> PDF file (lots of scrolling!)
- 2) It was difficult for users to find the information they wanted
- 3) Statistics weren't always placed alongside other related topics
- 4) The publication was not very accessible (e.g., alt text, colour schemes)

These typically are represented by Local Authority-level maps within the full PDF report.



- Claimant count Jobseeker's Allowance





- Original bulletin content merged with other sections relevant to the Rural economy to create the economic report forming part of the overall Digest publication.









Employment





Output & productivity (Gross Value Added)

Latest estimates show the productivity of Predominantly Rural areas (measured using GVA per workforce job) was around 84% of that for England as whole. There has been little change over recent years.

Businesses

In 2021/22, there were 554,100 businesses registered in Rural areas, accounting for 23% of all registered businesses in England.



Data source:

Inter-Departmental Business Register (**IDBR**) compiled by the Office for National Statistics. It is a comprehensive list of UK businesses used by government for statistical purposes.

Two main data sources are Value Added Tax (VAT) and Pay As You Earn (PAYE) records from HMRC. The IDBR covers around 2.7 million businesses in all sectors of the economy, but since the main two tax sources have thresholds, very small businesses operating below these will, in most cases, not be included.

Secondary Education – Digest update


Previously, we only had statistics for the **proportion of pupils passing their English and Maths GCSEs**, by pupil residence, school location, and IDACI decile.

We have now developed the section to reflect the headlines used by DfE:

Key facts

On average GCSE level attainment is higher for students living in Rural areas than for those living in urban areas but in recent years they have been less likely to enter the collection of subjects that make up the English Baccalaureate.



To support understanding of the new metrics, we have added in a **background information** section right after the summary.

This will help to ensure users understand the differences between the new statistics, as well as what they actually mean.

English Baccalaureate (EBacc)

The EBacc is a set of subjects at GCSE-level that keeps young people's options open for further study and future careers.

The EBacc consists of:

- English language and literature
- maths

























Expressed as a proportion of the maximum score for indicated year

Attainment 8




Expressed as a proportion of the maximum score for indicated year
