# **Key Learning Points**

# Connecting Culture, Regeneration, and the Community to Attract and Retain our 16–34-year-olds

- Interlocking a number of projects <u>Heritage Action Zones</u> and <u>Skipton's High</u> Street Heritage Action Zone; rejuvenating the High Street
- <u>Skipton Station Triangle Masterplan</u>; <u>Transforming Cities Fund</u> and <u>Skipton's</u> <u>plan is part of a bigger bid from Leeds City Region</u>, sorting out transport links and greener transport.
- Great Place Lakes and Dales looking at art, heritage and culture and supporting young people.
- Developing a cultural Hub for Craven DC <u>Skipton Town Hall</u>
- Invite your funders in and show them/demonstrate the vision.
- **Get your community onboard** engage with them and invest the time to do this as many hurdles to overcome.
- Success Breeds Success...and more Grants.

Rural co-working: New Network Spaces in the Rural Economy



- The need for working hubs as well as cultural hubs to improve/influence rural economies.
- Stimulate new working connections as well as sustain local social networks
- **Need to capture high earner skills** within the community and show young people that they can work in a rural area and not leave.
- Reposition rural co-workers into the centre need superfast broadband
- **Different models** but community led models are about community and wellbeing.
- Research shows the shift away from London to smaller urban hubs and commuting towns.
- <u>iNCITE</u> Northumbria Centre for Innovation Regional Transformation & Entrepreneurship.
- Blog from National Innovation Centre for Rural Enterprise (NICRE).

## Fair Levelling Up for Rural?

- Levelling up difficult to define so how do we know if it's been achieved.
- "Left behind" areas have low productivity, low earnings, low skill base and poor health.
- RSN report with Pragmatix Advisory bias in the metrics used towards northern, urban red-wall areas in the allocation criteria of the Levelling Up and other Funds.
- Community Renewal Fund is it going where it's needed?
- RSN survey on levelling up and the UK Shared Prosperity Fund. We would encourage you to complete this survey if you have made a bid to one of the recent Government Funds, whether you were successful or not, so that we can gather views on the process to feedback to Government. This survey closes on 19th December 2021.
- Need funding allocations to reflect cost of delivering services.
- Resources don't have to be the same amount just **fair and equitable**.
- Salvation Army report on Levelling Up.

## Any Other Key Outcomes from the Seminar

RSN's Revitalising Rural Campaign Specific Policy Asks of the Government is for fairer distribution of national resources to rural areas and more nuanced national policies. There are 14 Chapters in the campaign; one of them looks specifically at Rural Economies, and Rural Town Centres and High Streets.



As new Government strategies are announced, RSN puts them through a "Rural Lens Review" which adds depth and texture to the Policy Asks. A fresh crosscut of the Revitalising document being worked on will look in more depth at younger people. It will also look at the impact of various issues on younger people and develop case studies (personal experiences) rather than dry policy discussions. One of these reviews looks at Government Place Based Funds, Build Back Better High Streets.
