## 4. Any Other Business

Cllr Julia Huffer introduced her concerns over the development of solar farms in the countryside, and the impact on agricultural land. She also raised concerns over the lack of benefit for local residents from these solar farms. Richard Kirlew echoed some of her points.

Richard Kirlew also highlighted some work done by the Church of England into deprivation in rural communities.

Cllr Thornton raised the issue of the RSN being a cross party group and the need to convince political leaders of the current situation in rural communities and their needs.

Cllr Whittington shared concerns regarding rural deprivation providing examples from his local

authority area.

The meeting closed at 12:15pm
